Procedures for application and selection of high school choral performing groups.

1. **Application**, **audio recordings**, and **list of current repertoire** must be mailed, emailed, or submitted to by **June 20, 2025**:

# 2. Audio recording parameters:

- Recordings of two selections from current repertoire must be provided. Contrasting selections are recommended.
- Recordings should be submitted through our online submission portal at the following web address: https://spaces.hightail.com/uplink/mso.
  Be sure to include your school's name, email, and title and composer of works when you submit. Further instructions on how to submit can be found at mso.org/education under the competitions tab.
- The chorus applying must be the only chorus featured on the recording. Separate entries for different ensembles at your school are permitted.
- The current director must be the director for the 2025.26 season.
- Selections may be either accompanied or a cappella.
- Pop music should *not* be included.
- 3. All recordings and materials will be evaluated by the MSO in a blind screening.
- 4. Repertoire list must accompany application or entry will not be considered.
- 5. Invitations to perform with the MSO will be issued by July 22, 2025. Results will be sent to the chorus director's summer address.
- 6. Schools which participated in the 2024.25 program are not eligible for the 2025.26 program.
- 7. Selected schools will receive full concert program information by September 1, 2025. The purchase of music will be the responsibility of the schools.
- 8. Only schools in the state of Wisconsin are eligible to apply.

#### June 20, 2025

Applications, recordings, & repertoire lists due to MSO Education Department.

#### July 22, 2025

Invitations to perform will be issued to selected schools.

## September 1, 2025

Selected schools receive concert details.

#### September 22, 2025

Signed Statement of Understanding due from selected schools.

#### October 2025 TBD

Conductor will hold in-school rehearsals with participating choruses. A second visit may occur after January 1.

## December 1, 2025

Ensemble biographies and photos due to MSO.

#### January 2026 TBD

Final rosters due to MSO. Conductor-Piano Rehersal for all choruses together at the Bradley Symphony Center.

#### February 11, 2026

Orchestra rehearsal at Bradley Symphony Center 12:00 pm Warm-up 1:30–4:00 pm Rehearsal

## February 12, 2026

MSO Teen Choral Concert at Bradley Symphony Center 9:00 am Warm-up 10:15 am Performance
